3. I understand any request for refund must be received by the Christian Fellowship Church Finance Office within 30 days of the end of the 90 Day Tithing Challenge Period.
4. I understand if I tithe at the physical Christian Fellowship Church building, my tithe must be paid by check, or with a completed offering envelope, so that my tithe can be properly credited. If I tithe online, I understand I must be logged into my account so that my tithe can be properly credited.
5. I would like to test God's faithfulness by accepting the 90 Day Tithing Challenge. I agree that for the three-month period, my household will contribute to God through Christian Fellowship Church, and tithe equal to 10% of our income. At the end of the three-month period, if I am not convinced of God's faithfulness to bless my life as a result of my obedience to His Word, then I will be entitled to request a refund of the full amount of contributions made during that three-month period.
